Some have trudged through the mud for the Mass at the Boy's Orphanage at 6½, moon light, and the remainder with the children to get carriages to take them to Mark Cross – This is doubly sad as we could have had F<sup>r</sup> Frank Jarrett all this time with only a word from your Lordship, and there is no fear of the Jesuits wanting ever to keep a footing in such a desolate place as Mayf<sup>d</sup> without a single Catholic family to keep up a mission! and the poor labourers overstocked with Bible readers and Methodists! The place is only fit for an old priest like Father Jarrett who would not thank me most liked [sic] for thinking of it for him.

Now my dear Lord for the love of God do send someone for Sunday's Mass at least if the Chaplain is not yet ready.

I did thank you my Lord very gratefully for the offer of the Industrial but I think your Lordship does not remember that an <u>exchange</u> for the Training School was to be with the Convent at Hadham where our lease ends in September., ( & thus supply the staff )

I thing I ought to explain that the Archbishop never did decline our services, but the House which His Grace proposed could not be had, and in the meanwhile the Sacré Coeur Nuns came forward and applied to have the Training Sch<sup>1</sup> while the Archbishop imagined the correspondence on our part had ceased.

And now that I have explained the matter to your Lordship I shall think no more ab<sup>t</sup> it, unless it be to make an act of contrition for having taken up your precious time with these two letters.

My Lord & dr Father in Xt [Bishop Danell]

A thousand thanks for your kind letter & its enclosure which in one of its statements much more than astonishes me! I have letters to prove that the A.B. was anxious to have us to take the Training School & that I was twice called up to London by His Grace on this subject & for this object. Once to visit Harley House & once regarding the House in Dorset St which the Sacre Coeur had purchased. When that house was said to have been sold & when we failed in getting it, the Archbishop imagined our correspondence to have ceased. I certainly never withdrew our acceptance of the offer from the Poor School Committee & I should have thought that Mr Allies ought to have been one of the last persons to act against us considering all circumstances. Why he should do so I do not know unless it is that he fancies we have not the pecuniary means to keep up & maintain the School & on this point he is wonderfully far from the truth! Lord Petre also wished us to have the School, so if he has been induced to change his mind, it can only be through Mr Allies' influence and representations. I write this simply to explain the truth. It would have been preferable for us to have had the Training School in Southwark if practising Schools were to be had. We had the Staff & the means.

It is painful to me to have to inform your Lordship that Florence Colegrave, whom your Lordship saw at S<sup>t</sup> Leonards during your Visitation with F<sup>r</sup> Bosio, wishes me to write to second her application for a dispensation from her Vows, which terminate in September next – She is determined not to wait till her obligation ceases, and prefers taking the responsibility on herself rather than follow the advice given to her by her Superiors & Directors,

If you do not give her leave to go she will most likely give so much scandal that we shall regret it, or she will run off. Indeed she is at present a source of scandal to the children in the school especially to the English girls, who cannot understand her disobedient insolence – She is first cousin to M<sup>r</sup> Manby (Colegrave) the Apostate Priest, and the family temper clings to her. It is to be depolared [sic] that she ever was admitted to Vows even for three years yet very fortunate that they are of no longer duration. Her mother is a protestant and I have heard is as hot tempered as herself. The Extraordinary who was lately at the Convent at Toul, said that she neither feared God or Hell! If your Lordship would simply say that she is free to go you corroborate only that which the XX11 Rule provides for "If for any grave reasons any one should desire to leave "&c – added to which we are forced to say that she has proved herself unfit for religious life.

I have had several letters from her requesting to be allowed to go since I left Toul, and if she is not allowed to go I fear there may be serious difficulties with her protestant Mother.

I hasten to express my most grateful thanks for your letter, empowering me to convoke the Chapter, and also for the printed instructions  $w^h$  I  $rec^d$  by the last post yesterday. I am now writing to the several Convents to fulfil your Lordships expressed wishes, and to forward immediately the printed Instructions.

It will give your Lordship pleasure to know that I have had two interviews with Canon Fisher, & that his reverence came to Preston on Saturday last and put all things on their former footing. Mother Lucy made her act of submission in his presence, and promised to put aside all past grievances, real or supposed, &c &c and all is now at an end in past matters and the Sisters generally made happy by the return to former peace.

It is sad news to hear that F<sup>r</sup> Jarrett is on the eve of departure from the Orphanage & we must pray hard that he may remain with us! Our stay here has been prolonged beyond our usual time but the fruit of Canon Fisher's kind interference & D<sup>r</sup> Whitty's prudent advice will far more than repay us for the extra time spent here.

We shall all pray earnestly that matters may be settled for the good of all, and I will only call your Lordship's attention to the uniting of Hadham & London into one ,while the two communities at S<sup>t</sup> Ignatius & S<sup>t</sup> Walburgas in the same Town are made separate – At S<sup>t</sup> Ignatius's the Sisters with the Superior number five & at S<sup>t</sup> Walburgas they number six – Perhaps your Lordship may have left this matter to the Bishop of the Diocese to arrange.

Had there been sufficient time when your Lordship was here I should have explained more fully the work that required immediate attention & w<sup>h</sup> I spoke of some months ago. The roof over the upper class rooms requires to be raised, & we need another floor over it as soon as it can be done. The estimate for this work is three hundred & eighty five pounds - £385. As the time presses for the holidays, and we could not have the work done at any other time, I beg of your Lordship to send us leave to accept the estimate by telegram. They will secure the first floor being ready for the opening of our classes by the middle of September. We shall <u>not</u> use any Capital for the payments, but there is no time for delay in this necessity. We are hoping to see your Lordship on Wednesday please God.

My this mornings post I have received letters from M<sup>th</sup> Gertrude & M<sup>th</sup> Alphonsa saying that they had been to get the blessing of the Bishop of Liverpool and to make known their removal, but that his Lordship seemed displeased and said he did not even know the result of the elections nor that of the deliberations regarding the Rule. His Lordship also spoke of his conditions to the Election & said No. 2 forbade any removal – His Lordship asked if the 3<sup>rd</sup> condition had been fulfilled (one house and one Superior) –

His Lordship finished by ordering them to remain until His leave was given and said he acknowledged no changes at present in His own Diocese.

This matter rests with you my Lord and we were not prepared to find that the Bishop of Liverpool knew nothing of the Elections or of the change of the Rule and Constitutions.

We are here my Lord to assist in the removal from Hadham to London and have been obliged to decline the first lease proposed. Mother Angelica is with me. I had hoped to be absent from S<sup>t</sup> Leonards when M<sup>th</sup> Gertrude was to return that she might enter upon all her local duties without reference to me, but nothing can be done until your Lordship pleases to treat with the Bishop of Liverpool. We shall probably be detained here till the end of this week & then return to St Leonards.

We settled all at Mayfield last week, as far as possible, regarding the Noviciate – The offices, Division of the

House &c &c ., which can readily be completed by the Carpenter.

I hope something is settled for poor Mother Catherine regarding the Farm & the finances as her health will not bear much worry.

Crosses and upsets prove to us how little Christ-like we are, and how quickly the thermometer of supposed heroism falls to zero when put to the Test!

I think I ought to say to you my Lord that  $M^{th}$  Gertrude has sixty five boarders at Blackpool and that I am not surprised that the Bishop of Liverpool should not consent to a change, & I have no one to supply the amount of teaching required. If you will consent to two of the Assistants living at  $S^t$  Leonards for the present three years, & allow  $M^{th}$  Gertrude to remain there we should be relieved from these extreme difficulties. On all sides the work increases , and the health of the Sisters is giving way. If your Lordship will consider this amendment (!) we can propose it to the Council  $w^h$  is to meet  $ab^t$  the  $10^{th}$  of Oct. I am harassed to death with demands for more Sisters at each house than we can possibly supply – and as it is we are obliged to withdraw a Novice from Blackpool who was sent up to assist them in their great need early in the summer before the General Chapter.

I am very sorry to take up your Lordship [ 's ] precious time by this long letter, but I am sure your charity will see the necessity of acting in these emergencies.

Your letter was forwarded to me here, and I hasten to say that I have not a thought of going contrary to the wishes of the Bishop of Liverpool! I have not made a single move of Superiors or of the Sisters in in [sic] the Schools belonging to Lancashire, but I sent a Sister, who was not in any office or School, to Blackpool to assist in the work there, Mth Gertrude had asked for her when she came up since the chapter, and the Sister herself was ill at ease here, so that all parties were relieved by her going to Blackpool. And again I sent two Novices back to the Noviciate who had been at Blackpool one for her health & the other as a companion since last April, and we could not suppose that these could come under the restrictions of the Bishop of Liverpool.

We are going over to Liverpool to make a second visit to D<sup>r</sup> Fisher tomorrow & hope there may seen [sic] be more light as to matters here before long. We have been here since the 6<sup>th</sup> of November and I think all things could have been made clear & straight had we been free to carry out the elections, but great offence was given by the Secretary of the Chapter having failed to send the list of the Elections to the Bishop of Liverpool.

The present unsettled state of things is very bad for every body.

My best thanks for your kind letter & for the consolations your Lordship hopes for under the cross, - The "Perfect joy " of the Seraphic Father Francis of A! I wish most sincerely that your Lordship may have consolation elsewhere in proportion to the crosses from the North!

I write most particularly to you my Lord at this moment to express very frankly our total inability to keep that article of the Rule No: 3. Pg 47. regarding the acceptance of the <u>income</u> of those who voluntarily wish to assist our works both <u>Local</u> and General.

We have never received donations from the <u>Capital</u> of Novices, but we have always accepted their voluntary contributions of <u>income</u>, as other approved Orders are free to do, (returning them if claimed) – We only wish my Lord to have the same freedom & privileges for good works as other orders engaged in the active service of the Church, & not to be crippled by useless restrictions upon <u>income</u> – In fact at this moment we are under heavy liabilities, in advance of our income, so that we could not pretend to decline using all that we have accepted annually. What would the Notre Dame Sisters have done had they not received Mrs Petre ['s] income? or the Sacre Coeur, &c and we cannot understand why anyone using her income in works of Charity should, because she is in religion, be forced to increase her Capital by hoarding it up! I am sure my Lord you only want what is just & right as we also most sincerely do, and I now send your Lordship a sheet of the building expenses at

Mayfield which we completed this year to the amount of £4700 – You will remember my Lord that you sanctioned the raising of

£2500 by a mortgage on the property – The remaining sum of £2200 we have not borrowed but have paid in <u>advance of our income</u>. Besides this large sum we have the Contract for £385 with extras £40 and this brings us to £2625 without touching a farthing of Capital.

I simply make this statement to shew your Lordship that these liabilities were incurred before any restrictions were imposed upon us and that a law or Rule which did not exist at the time they were incurred cannot be binding on our conscience, at least till we have have [sic] paid off our debts incurred by these liabilities.

We also feel deeply that future good would be very gravely retarded if not quite lost by restrictions on an income that would be spent in the world & yet forced to be hoarded up in religion against the will of the owners.-

The third part of the corrected Rule was safely received yesterday – Thanks. Mother Veronica had translated from the first copy sent, so that it was ready to go to Father Bosio immediately.

The printer in the Town is doing the first part  $w^h$   $F^r$  Bosio corrected – It was not possible for us to undertake it ourselves having several Sisters ill and ill also myself.

Mother Angelica is in Preston with M<sup>th</sup> Gertrude arranging to meet the views of the Bishop of Liverpool in amalgamating the three Houses there. There are many difficulties but I think they must and will be met. M<sup>th</sup> Lucy is under M<sup>th</sup> de Britto in Blackpool & M<sup>th</sup> Gertrude has taken her place at S<sup>t</sup> Wilfrids until we can find a house that will accommodate twenty two Sisters.

Would it not be better not to translate the Second part of the Rule under the present objections & difficulties? There are several objections on the part of the community as well as from the Bishop of Liverpool who told our Sisters that he did not acknowledge it! We should only have to reprint the corrections and we shall not get it done for less than £20. The Printer was obliged to buy new type for that which he has done because of the accents on the letters & the number of 's to be used.

I wish we could send a large subscription for your seminary, but Mayfield & our buildings here have thrown us beyond our income in advance & we have to be very watchful over our expenses till all anxiety is over, and then beware of future contracts-: we invariably drag you into at least

a third more than you expect.

I wish the Marquis of Bute would pay off & endow your Seminary and leave your Lordship no more anxiety to kill its victim by inches as it does very often.

Mother Angelica & M<sup>r</sup> [Mother] Aloysia will present your Lordship the copies of the Minutes that you require. Of course the Books could not be removed from the Archives.

It would be a sad thing indeed if the Constitutions had not provided for such cases as this of M<sup>th</sup> Alphonsas. Happily they are expressly provided for, as your Lordship will prove on examining, Section V article 6<sup>th</sup> pg 38. where it is stated they "may be deprived of their respective offices" within the period of three years" – The Constitutions do not say, for anything the individual may have done, or for any misbehaviour, but simply "for grave reasons" M<sup>th</sup> Alphonsa has no right whatever to claim exemptions. We had the decisions of the Council, the expressed determination of the Bishop of Liverpool, and your Lordship's approbation of the amalgamation of the three houses before it was made, and the election of M<sup>th</sup> Gertrude was confirmed both by your Lordship & by the Bishop of Liverpool.

The reasons for the amalgamation were undoubtedly <u>most grave</u>, and D<sup>r</sup> OReilly totally rejected the election of the three Superiors. All this was done lawfully according to the Constitutions & to the rights claimed by the Bishop of Liverpool.

The removal of M<sup>th</sup> Alphonsa to Mark Cross is a temporary measure and I am quite sure that M<sup>th</sup> Cath<sup>ne</sup> would not accept of M<sup>th</sup> Alphonsas presence in the Community under the anomalous position of one not under her direct control as a

subject, nor could I conscientiously impose a burden that I would not myself accept. If your Lordship does not

In reply to your L's kind letter I hasten to say that Mary A. Kelly was a lay S<sup>r</sup> with us, who made her own appeal to the Cardinal from the Convent at Hendon about a year ago for dispensation from her Vows. Her Mother wished also to take her into service where she & her husband had been employed I understood for many years. Mary Anne had never been quite satisfactory in religion & during the last few years her conduct was particularly disedifying, so that we all readily assented to her appeal for dispensation, which was wholly her own act.

When she left the Convent at Hendon, we provided a box of Clothing such as we thought suitable for her & sent her a Cheque for £10. The Clothing (external) was not what she wished it to be, & we sent her £7 extra to purchase what she herself wished to have. She had not left us very long before she wrote again for money for port wine &c. We have taken no notice of these letters as we do not give credit to the alleged "Doctor's bill " or to the need of wine &c beyond the living they have in the service of that gentleman's family. I heard that she had received £2 from the Cardinal's Secretary before it was possible for her to have used up the money we gave her for her own wants. I think the poor girl is the tool of her Mother in this begging.

She went to se the SS. in Nottingham Place & she has also been out to Hendon. She was with us in the little Orphanage

at S<sup>t</sup> Leonards & was then a good girl, but the chief part of her religious life was spent between London, the Culvers, and Hendon. This is I think all I can say about her & I hope the money she has received may not have been worse than wasted, though this is very doubtful.

My Lord & dear Father in X<sup>t</sup> [Bishop Danell]

Your letter was forwarded to me by this mornings post & I have requested M<sup>th</sup> de Britto to send a copy of the printed Rules to your Lordship immediately. The Book should have been sent last week but there were several mis-prints w<sup>h</sup> I wished to have corrected, & the errata printed, to put into each book before sending it & this sh<sup>ld</sup> have been done last week had we been sure that nothing had escaped our observation.

The Sisters in general and universally seem very happy ab<sup>t</sup> the Rule excepting the second year Novices not being at the Mother House for their training in the employments they will be bound to fulfil when under Vows – We do not think it quite just to them, nor do we think we have a fair chance of knowing them or trying their characters, qualities & abilities in the small Community at Mayfield. All would have been well if the Rule had been left in regard to the second year Novices, as it was in the first year.

the Head of the House in which she lives, with a Vicaress in charge to take all the duties the Head may impose upon her. This was what F<sup>r</sup> Bosio at first proposed, and it was the wisest plan, and the one that would work practically amongst women as far as my own experience goes. Young Superiors are always disposed to act independently, and to undo what their predecessors have already done, and this with the best intention & without any wilful fault. Believe me, my Lord, I am not speaking personally, but for the sole view of the future. I do not mean to say that my heart has not been cut a thousand times, & when no one but God has known of it amongst my numerous imperfections & faults, but my portion lies in this by the sweet Will of God. — Another may not relish such a portion especially if younger than myself. Perhaps your Lordship will think over this point before the next election & get information as to the position of the General in other orders, where the work is carried on with great advantage to the glory of God & the good of souls.

I hope your Lordship has not been too much fatigued by all labours of the Summer months, and we have had a beautiful Autumn which has generally proved healthful so far. I wish I could give a better account of myself but the least worry tells upon my system & nerves from which I never suffered until this year, still I am gradually getting stronger.
