By advice received from the Rev Father Lambert I write to your Reverence for necessary information as to how we ought to proceed in order to obtain the advantage of a Cardinal Protector in our present troubles & anxieties.

I must explain that we are in various complications with our venerated Bishops chiefly originating in our being now under the trial of a New Rule given to us by our Bishop, His Lordship of Southwark, which is not of the same spirit as the one upon which we made our Vows, and which we have practiced [sic] since our foundation in the year 1846.

This new Rule the Bishop of Southwark has given to us to translate into Italian, that His Lordship may present it to Propaganda F. for approbation. It is now printed & nearly ready to be forwarded, and His Lordship has intimated to us that we are free to send any remarks we may wish to make upon it.

Certain complications have already arisen from the Bishop of the Mother House being made in this new Rule the Bishop Superior of the Institute, but there are also other complications, which we fear would greatly impede the work, if not finally ruin it.

May I under these circumstances ask you kindly to suggest to me how we should state our objections regarding these changes and to whom they should be represented?

Also whether it would be advisable to have our notes drawn up and signed only by the Sup: Gen¹ and her four Assistants, or by these and the local Superiors of each House? We wish as much as possible to avoid any excitement in the minds of the various Communities.

We are under the impression that with a Cardinal Protector we shall be quite safe in complying with any changes that may be made or added to our Rules & Constitutions, and that we may thus securely avoid the threatened schisms in the order, and that this alone can preserve our Communities in America as well as in England & France.

Many thanks for your kind letter and for the information conveyed respecting my dear child and my other relatives whom I commend to your holy prayers. Thanks also for the kind expressions you use in regard to our dear Sisters at Towanda and for the frank way in which you question me on the subject of our Institute which I truly appreciate and which will at once put our mutual understanding on a clear footing.

I will now try to answer your questions. You ask me what authority the Bishop has over our SS? First – His Lordship has the jurisdiction over all our Houses founded in his diocese – he names the Confessor of the Community (and as far as possible there is but one Confessor for all) and he is our Ecclesiastical Superior. He gives leave to receive Novices and either invests them himself with the holy Habit & Veil or delegates another to do so. and he alone receives the Vows of the Sisters or delegates another to receive them.

If it is left to the disposition of the Superioress by the [donor] the house in which it is received always has the first consideration- And no property belonging to a Convent in America would be paid over to another Country but the disposition of any property of great value would be referred to the Mother General not in order to avert it but to use it for the

advantage of the province to which it belongs. So far from the centre of any pecuniary interest lying in the Mother House, the case is quite the reverse. No Educational Order could ever flourish to any extent in unity of purpose and in effective work unless a certain bond of union exists between the branches & the parent stem nor could there be the freedom of action necessary for an Educational Order were we tied down to the restrictions of cloistered nuns and obliged to seek the restrictions [sic] an external authority for effecting the internal details of our ordinary duties and arrangements. Our whole life is devoted to the service of God & the good of souls in our intercourse with our pupils and with the persons of the world connected with them or with our Sisters – and this life is one of no ordinary sacrifice in which our own perfection and salvation are included. 2ndly Our Sisters may be removed by the Mother General or by one empowered by her to remove them but as few changes are made as possible and then only on account of some greater advantage either for the Individual herself or for some other good object.

These are the clearest answers I can give you dear Revd Father but if you want more than I have made and understood from your letter pray write again with the same frankness and I will be glad to answer more fully if I can – but I think you need not fear that the Sisters would fail in entering into the wishes of your zealous and generous Bishop as far as he thinks desirable and consistent with their Vocation. Still if I may presume to say so it

seems to me better that you should not engage the Bishop in any fresh foundation but rather wait for a year or two until he sees for himself how the SS are likely to work their way at Towanda – whether the general good among the poor and also among the upper classes of children is equal to the Expectation of His Lordship and whether the same work would be likely to effect the same good in Philadelphia. He would thus be able to judge of the probable loss or gain in a future foundation on his own judgement of the probabilities of the one or the other. I hope dear Revd Father you will agree with me in thinking it will be better to let the SS work their own way out of their difficulties at Towanda. I have requested them to dismiss all workmen, and if any future building is to be done by a contract made in writing and approved by the Bishop. Unfortunately they took the kindly expressions of the good Bishop in a larger sense than he evidently intended and have no doubt wasted their money. Poor children! they must purchase their experience before they can quite possess much of it. They thought they were doing right in making the place suitable for future work as the Bishop advised. What I have said about their remaining at Towanda and not going to Philadelphia is not from any thought that the Bishop would not be pleased in the end, but solely not to go in advance of H Lordship's own judgement. On the contrary I think he will be more than pleased with the results at Towanda & that he will be in the end quite satisfied that the spirit of humility charity and zeal of our SS wd be always guided by the director placed over them by the Bishop, and after all this is the safest and best of all kinds of authority.

It is a great pleasure to know that you are pleased in having the Sisters so soon at work in your Schools, and I thank God with all my heart that we have been able to meet your views in sending them. Any arrangement you wish to make for the Boarding School and Noviciate, that can be met by Contracts for timber or mining on the Lycoming Lands we shall be most happy to consent to but we dare not contract any debts, nor can we sell the land as it would give great offence to the Duchess of Leeds.

Any <u>contracts</u> that the Bishop and yourself think desirable to be made, and to be invested in a Noviciate and Boarding School, pray take the power to do with our full consent – What you and the Bishop think right for the Community to take upon themselves in the purchase of a Noviciate we fully consent to, but we cannot make this province answerable for the purchase of any property, nor for any debts or mortgages. It may be that it would be better to exchange Towanda Convent for another more desirable position, but the Duchess would not listen to such a change and for the

perseverance of carrying out what is once begun I had rather keep it up with the hope of one conversion in the year among the protestant children than to exchange it, or to give up what has been begun with the full consent & approbation of Dr. Wood. I have great faith in this, and once a good work is afloat on rightful authority we can go on with spirit and untiring determination – The town is growing and no doubt the Mission there will grow into importance with it, in ten years or less perhaps - There is no doubt they can support themselves in the Schools, the living being low, and for ourselves we had rather send out 3 more Sisters next Summer than to give up Towanda – even with only one conversion in a year – and by their own industry, they might support a chaplain which would at once make them comfortable and happy in their position – We shall pray very much for the prosperity of the first foundation in America and hope never to part with it. How shall I thank you enough for your very kind letter & for the welcome intelligence you give regarding our dear Sisters - You know that I do thank you very very much for every kindness you show them and for your kind invitation to me, which I must only hope to accept later & when there might [be] some hope of usefulness to satisfy my conscience in the proposal of a journey which would give me so much pleasure! And you know I must think of my poor soul first & the innocent pleasure second – Would that I could promise you all you ask for the opening of a Noviciate and we must pray that our dr Lord may enable us to meet your wants at least in some measure if you decide upon getting the proposed country house – I should think the one that is nearest the railway & the best fitted up would be much the best purchase of the two proposed that is the one at Shoemaker Town near German Town - & they would be saved much immediate expense by the fittings being suited to their wants more particularly at a time when labor is increased in value & everything so dear that is bought new – I presume some contract could be made for the timber on the Lycoming lands that could be devoted to the purchase of the furniture if the property is secured. it easy to make some contract also for the coal mines & for an Irish settlement on those lands where at this time there are thousands of suffering poor emigrating to the States from England as well as Ireland. Of course Mth M. Xa will be advised to do her best & she will use the money, from any future contracts for the Novitiate in one way or another as seems best, & she is perfectly free to do so but not to sell the land. If she had begun at first at Phil. the funds spent at Towanda would have been at her disposal now, but God disposed otherwise & we must see His hand in the past as all was done in obedience & for the best.

Will you tell the Bishop I hear of his inventions about mitre bribing & all that sort of thing. Now is it not glorious to give bribes to be allowed to suffer and work! really the idea is worthy of the martyrs – I wonder if the second colony had to give a bribe! & whether the third must follow on! Tell his Lordship to let me know what the bribe must be – He is so rich in mitres and vestments of all sorts that nothing can be got up worthy of the name. I read the acct. of the carriage but after all its wheels are too heavy for the road to Heaven, though some are said to take the road in a carriage – His carriage will no doubt help him to many works that will carry him speedily on his way & we all congratulate him on the gifts and on the way it was given.

Very Rev and dear Father in Xt. [Fr Carter]

Your most kind letter bearing the news of your magnificent purchase of Sharon House reached me on my journey to the Convents in the north of England and I am almost afraid that this will be too late for to morrows mail which must if possible take our best and most grateful acknowledgements to you. I need not say that no effort on my part shall fail in sending you three or four Sisters to assist in carrying on the work in the most efficient way. I have already told M.M.Xavier that she could close the House at Towanda to meet your views if Sharon House should be purchased so that I hope she will be in no doubt herself & that you will be immediately relieved from any anxiety on that point. The Bishop's wish would have been enough even had you not purchased Sharon House. I also told her some time ago that she could appropriate any money received from contracts or rents to any purpose you might require – even for furniture which is very perishable and hardly to be looked upon as an investment. I have not the power myself to sell without the consent of my council and chapter – and as regards the property given by the Duchess of Leeds, we must respect the wishes of the donor and I think I could hardly offend her more than by a proposition to sell her lands – The contracts for timber or mining must therefore be all that can avail us in the present case as regards the land. But your Reverence & the Bishop will best know how to advise regarding the letting or contracting

for the house at Towanda . It will certainly go to ruin if lef [t] without a tenant. I had promised myself the pleasure of writing to you regarding Mayfield a week ago, but being occupied with many duties I only now find a free moment. What I proposed to the Rev^d F^r Gallwey was, that one of your fathers should come from Tunbridge Wells on friday [sic] Ev^g & remain at Mayfield until Sunday morning, giving us two Masses a week, Saturday & Sunday, & two Benedictions, also hearing the Confessions. I proposed that the conveyance should be sent from Mayfield there & back, coming & going, & that we should provide board & lodging during the time the Rev^d F^r remains with us. The salary offered was £50 per an: until we could make other arrangements for a resident Priest at the Bishop's convenience. I shall be happy to know whether you would be willing to enter into this arrangement for the Summer months, and later we should see whether there are any unforeseen objections on either side. We have permission from the Bishop for Holy Mass, but not yet for having the Blessed Sacrament kept in the Oratory.

My dear Rev^d Father,

I am extremely sorry you should have been pained & displeased by the contents of my letter, nor should I have supposed that the Boarding of 6 children in the Convent could be looked upon as a question seriously affecting the spiritual good of S^t W's Congregation. It seems to me simply a question of the comfort, convenience & well being of the Convent. I was not induced to look into the subject with any other view than the fulfilment of my duty, first in regard to the health of the Sisters, & 2^{ndly} in regard to the Children themselves who could not be properly, or even healthfully lodged nor superintended as they ought to be.

When I thought of & proposed Blackpool, it was for their advantage solely. There need be no competition between the schools, but all parties should work for the general good in cases of necessity & it would have been a favour to the children themselves & not to Blackpool, if they had been accepted there. I am more than amazed that anyone should wish to cramp the Community with Boarders when the dark Convent & narrow passages are already constant subjects of annoyance, added to another daily incommodity. The large and beautiful Day Schools ought to be kept up with every advantage & not be interfered with by boarders. Surely there are many respectable Catholics who would be glad to take care of such as

have no home, until the Children can be received as pupil-teachers & for such there is suitable accommodation at S^t Walburga's & St. Ignatius' Convents

I hope my dear Rev^d Father you will look to the good of the Community in this question, uninfluenced by <u>anyone's</u> wilfulness. I am not aware of either will or determination of any sort, further than duty and justice to all parties concerned, & shall be glad to hear from you simply that I am right. I have also proposed that he should wait for a rise in the funds if they are very low just now as it would be a pity to sacrifice any portion of the very small capital for the purchase of an annuity.

2ndly with regard to the Vows, I consider <u>fugitives</u> as <u>ipso facto</u> excommunicated but "If for any grave reasons anyone should desire to leave the Society before the time of her last Vows, necessarily (ipso facto) she will be released from the obligation of her Simple Vows. "Those who judge of the very grave reasons are the Superior and Director & certainly not the Individual. The ipso facto refers only to the fact of the very grave reasons and this is understood in the Community, but if it admits of a doubt the "ipso facto "had better be expunged. It is not in the Italian Rule but the "necessariamente" takes its place & also refers to the "gravi ragioni". Many grateful thanks for your kind care of this poor Miss Harcourt. As soon as I know what is settled for her annuity, I could write to some of our friends in Paris & try to get a position for her that would be respectable & safe.

I beg of your reverence to relieve me from all anxiety regarding this mysterious affair as soon as possible and immediately – For the sake of her health alone a removal is necessary

I write now to ask you to interest yourself at the Meeting of the P.S.C. in Low Week, in the proposal of a London T.S. where the Students could be exercised in teaching in large practising Schools. I am quite sure that we only need a little energy & activity to bring the matter to a close without any question of expense to the P.S.C. beyond the usual aid given to the Livpl T.S. I ought to add that the N.D. SS do not [only not] object to another T.S ,but they think it would be a special advantage to have 2 Normal Colleges of different teaching Orders – I mean conducted by different Orders. I beg to thank you very much for your kind letter & for the interest you take in S^r Mary Joseph's welfare. I could not arrange quite as you desired for M^r M^y Veronica but I have requested Mother Gertrude to take over a Sister to replace temporarily M. M^y Veronica who is anxious to be removed. Will you allow me to say Rev^d & d^r Father that I do not think any Sister will have success in her Office as head in charge if the Manager of the Schools acts with the Sisters without reference to the one in charge. It appears that this has always been the case at St Walburga's, or at least it has always been so represented to me as the fact. The present failure is simply a following of all the former failures [sic] cases. No one has ever been equal to the position of acting in submission to those she was obliged to govern! Indeed My dear Rev^d Father I thought it would be impossible to keep the schools under these circumstances & that we should be forced to give them up, rather than encounter a continuance of such disorders in religious discipline. Formerly it was the constant reference by the Sisters to another Superior in the Town, but this has not been the case of late. It seems rather to lie in the Superior not having been sustained or respected in her office. I do not say this to blame anyone, but simply that you may forsee a similar result if the same course is pursued.

How [sic] However the Schools at St Walburga's may

have hitherto flourished, it is very certain it has been at the expense of the peace & comfort of the Community.

It is a pity not to have the sung Mass on Sunday, but we must be content with the Choir Music if you cannot sing. Perhaps you are depreciating your abilities as a preacher. I thought I mentioned that you would be served from the Convent & attended in the house by the wife of the bailiff who is paid by us for her services

There is no direct communication with Reading or London at present. We are five or six miles from the nearest station, but another railway is now about to be laid & will probably be begun next month to open on Mayfield direct to T. Wells & then there will be no need of a cab which may always be had from the Inn. Perhaps you wd rather have our Convent at St Leonards, & if so I would have no objection to mention it to the Bishop. The yearly sum here is £100 & house found

Our Bishop generally likes to change our Confessor every 3 years when serving as Chaplain at Convents but I presume there is no necessity for the change unless the Chaplain gets tired of his work, or that his health fails or because of the many unforeseen events of this life makes a change desirable.

Not only of the remembrance of the kindness received from your reverence some years ago at Rome, together with the great veneration I have for the Soc. Jesu, induces me to write and solicit your prayers at a moment of trial & affliction to our community and to myself; but other motives still more pressing urge me to do so.

You are aware that the Rev^d D^r Melia has been with us during the last few months, having remained after giving us a retreat; and tho' he had refused to come for the purpose of remaining before that time, yet, the Bishop finding it very necessary for him to do so, we have prevailed upon him to stop.

We can never be sufficiently be thankful to Divine Providence for sending in our urgent necessities a a [sic] Priest of so clear an understanding and of so simple yet strong a manner of acting. He has a laborious charge at present, having two missions connected with this within a circuit of 20 miles; but we pray & hope you may be induced to make arrangements with Bishop Wiseman for his remaining with us at least till our Monastery is quite settled, and a solid foundation of religious virtue secured.

It will be useless for me to do more than give you an idea of the necessity we are in, being a young Community chiefly converts, requiring a truly religious training:

this consideration together with the care of the schools, where there are 123 girls & 40 boys, may, I trust, claim some portion of your notice & of your charity.

The missions too, are not the less worthy of your notice as they promise in future a plentiful harvest. You perhaps may have heard of the conversion of two Puseyite clergymen, Mr Garside and M^r Cavendish & of the Hon^{ble} C^{pt} Packenham of the Queens Ist Guards, who were received by [sic] into the Church by D^r Melia. – These and many other conversions of less note give us encouragement in the ways of God & in tending ever towards the practice of virtue, in the true path of perfection.

Having mentioned to D^r Melia that I intended writing to your reverence, he desires me to say that he hopes you received his last letter, sent just before the receipt of one from you.

I have to thank you for your kind letter & for the Certificates for the second year Students. The Medal for J.Ryan I presume was not sent by the same post, as it has not made its appearance.

With regard to the result of the Examination I am convinced that the inferiority is not because of any deficiency on the part of the Students or their course of study . If it is true that three of the Inspectors or Examiners belong to the Diocese of Liverpool and only one to this Diocese, it would not be surprising that Liverpool should carry their prizes - If also it be true that the questions are drawn up by the Liverpool Priests, who are in constant communication with the Students, and still more if the one who draws up the questions teaches or gives lectures to the children there could of course be few chances in favour of St Leonards , or even if the Liverpool Priest draws up the questions he more or less has communication with the School, and draws the questions to suit the lessons they have learnt by heart — which no doubt would cause a great similarity in the writing (composition) [sic] a fact which would be sharply criticised , if not condemned, in an Examination held by

the Council Office Examiners. I think that justice demands quite as strict a secrecy as to the

questions in the one as in the other, and if a Liverpool priest draw up the questions for their School, one equally interested ought to do the same for the St Leonards School. The very fact that the Liverpool papers are so much alike would condemn them at the Council Office, even supposing there was not a possibility of their being particularly prepared for certain questions.

You must not suppose that I intend to cast any imputation upon anyone – I do not – but the facts certainly deserve investigation and I trust they may have it, for the satisfaction of everyone and for justice sake.

I think you will like to know the result of my visit to the A. Bp. who sent for me through Provost Hunt.

- 1st. It seems there is every probability that the house proposed by the A. Bp. would be capable of being made all that we should desire if the Lease can be secured.
- 2. The number of P.Teachers is still uncertain & this we ought to ascertain, though I do not see how we may do so unless we can get a Diocesan report of each District such as this of the A. Diocese which shews 70 P. Teachers for 1872, giving an average of 14 P.T's of the fifth year, for this one Diocese. It is supposed that Southwark would give about the same number. -? I presume that hitherto the demand for Teachers in the P.S.'s has encouraged the fifth year P.T.'s to take Schools rather than to follow up the advantage offered in the T.S., as certainly the numbers trained do not amount to much more than one tenth of our supposed average. We may however count upon from 15 to 20 each year. Mr Stokes gives an exact table of the Lancashire P.T's in his report for 1871, but I can find nothing for the Southern & Midland Districts. I notice also a table in Mr Stokes' Report for 1869

showing the whole number of P.T's R. Cath. from 1861 to 1868 to be average upwards of 500 each year. In 1868 the number was 543- Average for 5th year 108, & of these 36 only were admitted for Exam^r for Q.S. & in

1861 on an average of 109, 64 P.T.s were admitted to the Ex Q.S. This is a most wonderful fall! It seems a great pity that the T.S. was not opened in London in 1863 at the time we gave it up at St Leonards. But there was no co-operative spirit to propose or to second such a move. It might have been done & we could have worked it out ourselves- but up-hill work requires encouragement and cannot resist hostility or prejudice beyond a certain extent - & thus the work of God is lost! Even now it seems only the A.B.yourself & the S.P. Priests care about it- Mr Allies says he is not opposed to a London T.S. – but no doubt there is, if not an apathy, at least a want of spirit some where for the general good. We must not say every where. We need a living influence & more unity of action among the Managers of P.S's to keep the P.T. & everybody up to the mark! Well we must be humble - & do the best possible, and this at least will be for the honour of God and His Church.

To return to the points in question-

- !st The numbers. I suppose we may count upon 15 P.T. each year; this would bring us to 30 students for the 2 years Is this correct or not?-
- 2. The A.B. gave me the impression that Fr Rowe and Mr A. are against the move & that you and F. Richards would have a struggle to gain your point. You will see at once that I do not understand the position of Fr Rowe, nor what he had to do with the question but I feel quite sure that Mr A. wd not be against it if no further expense is to be incurred by the P.S. Committee. He is quite a friend as far as we are concerned but the interest (pecuniary) of

the C. is an important duty, and besides this two Schools will give more trouble than one I have taken up too much of your time in this long letter & now I will only add that I am dear Father

I am amazed at the number you mention as certain and it seems impossible that the A.B. could have realized the fact! It is a great pity that so much time has been lost on the question & if it is not too late for arrangements for this year could not your P. Teachers go to the London Training Schools for examination? If we can have 3 or 4 energetic Managers there is still a possibility of being able to open the T.S. in January. There will be no difficulty on our part whatever. We have an ample staff of Teachers, & could remove at any moment from the Culvers. The point now regards the Lease of the house, also the naming of Managers. I shall write by the next post to the A.B. & if the Managers cannot act with the Educ. Dept. under the A.B., I presume His Grace has only to request a meeting of the P.S. Com. for it to be carried out. If you will tell me when the meeting is to be held I should most willingly write to the members I may know to prevent any opposition. What folly to put off to another year to the loss of those poor Girls who cannot go so far as Lpl for Ex! If they go to Lpl. do they return & wait for the result of the Ex! then return again? St. Leonards was thought to be too long a journey, but a double trip to Liverpool is quite heroic! If you are making any Ex in our neighbourhood I wish you would pay us a visit en route.

Dear Canon Wenham

I send you a letter received from F. Johnson this morning. If you are willing to act in the matter for us with the Poor School Committee, pray do so. I am quite ready to carry out what Fr Johnson says regarding the purchase of the house provided we can make sure of the £1000 for the repairs and building without which it would be useless as a Training School. If the Education Fund or other assistance can be had for the Building it will be all the same to us to pay down £1000 or to expend it on the necessary repairs & dormitories. I should not like to have Gov^t aid on the building as we should want to purchase again at the end of this 15 years' lease. And it would be as well to keep on the Mortgage as long as possible till we have the money in hand - Mr New, who is our London lawyer, is the one employed by the R. Nuns, & Mr Sills is away, but if you like to employ any other in whom you have confidence, do so, & we shall be ready to act with him. Believe me to be

The inclosed is most satisfactory – Thanks – I thought I could not do wrong in writing to Mr Allies as you had before advised my writing to him. Besides this I have always looked upon him as a personal friend of ours; & doubly so from having had the education of his two children from their earliest [sic] early childhood. What do you advise now as to my writing again to him to say that in whatever way he may feel himself pledged to the Livp. T.S. that I hope he will second any movement that may be made in the next meeting in favour of a second T.S. in London, since I am quite certain that the Lpl. T.S. Sisters feel that it will be an advantage to all the Schools to have two Normal Colleges & that the north of England & Scotland will supply 100 Students—I am quite ready to enlist his favour if you see no objection to my doing so & at the same time to write to Ld Petre & others. I have requested M. Angelica to copy the letters I received from the Vicar General regarding the removal of $\underline{S^r}$ de Borgia . It was of this Sister the Vicar General spoke to me on the 27^{th} of June.

The first time that D^r Fisher spoke to me of Mth Eulalia's removal was on the 12th of November 1874 in his own room at the College- Everton – Liverpool. Mother Angelica was witness to my astonishment and D^r Fisher did not allude to having ever spoken to me on this subject before. He certainly never did. When I saw D^r Fisher on the 27th S^r de Borgia's removal was requested, and I replied that as the Elections were so soon to be made, it would be better to make no changes at present, to which His Reverence assented. (besides this in S^r de Borgia's case the V. General refers to the Decree of Visitation in which the removal of Superiors is alone mentioned.

It was with Your Reverence alone that I conversed about M. Eulalia & then not of any removal you will remember, but only of being rather disappointed & -

I only enter upon this for the sake of clearness to put to light the truth – The Bishop of Liverpool has been misinformed on more than one point! But there is no use in trying to clear up matters that are all one-sided & without any just redress.

I do not know that there is any particular use in

writing this to you, but I feel more comfortable to put it in writing under the present circumstances when the evil spirits seem to work triumphantly,

Father that a matter of so much importance requires time and consideration, and certainly as to the means to effect what is proposed. May I beg your prayers Revd. Father for our dear children who are on the eve of a Retreat preparatory to their First Communion? – and also for our students of the Training School who are to meet the Government Examination during the Octave of the Immaculate Conception B.V.M.?

-It is a critical moment for these poor Girls, many of whose families are dependent upon them.

- 6th. That a place in the graveyard be appropriated for the Convent, in case of the death of any of the Community devoted to your work.

I do not remember any other points at present-, but as I hope to visit Preston about the 15^{th} or 20th

Very Rev^d & dear Vicar General

Many thanks for your kind answer to my telegram. The ceremony went off beautifully and the dear Bishop sent a telegram from Rome to give leave which we received not long after your answer arrived.

Private & confidential.

I am very sorry to trouble you again ab^t Mayfield, but I am informed that things are worse there than ever. If it is impossible to find anyone to exchange it would be better for them to be without a Priest at least for a time & however inconvenient, the Sisters and children could go to one of the Orphanages for Mass & Communion.

I was told that Mons de Th: [ury] had said that if the Bishop asked if Marie was there he would take her up to London with him, so that he could say, No- !! – French intrigue & untruthfulness become extremely scandalous to honest english minds & what it- [sic] becomes of any confidence when added to this there is the double evil of a feminine influence! It cannot go on – and if y^r reverence would ask F^r Baron or Mr Tunstall what they think of the state of things at Mayfield you would very soon know that I have not exaggerated the necessity of a change.

I am very <u>very</u> sorry to trouble you ab^t these matters but the duty is forced upon me.

Is it true that we may hope the Bishop may return tomorrow?

The managers of the Girls Schools having duly weighed the difficulties urged by the Superiors of the Convent have come to the following conclusions.

- 1st Tho' most willing to consider the reasons and difficulties of the Sisters they cannot relinquish the right of finally deciding for themselves- each for his own School the number of Sisters to be employed in each School as also the most expedient time for commencing the vacations.
- 2^{ly} On this last point the managers feel bound to adhere to the decision already come to of beginning the summer holidays on Whitsun Eve.
- With regard to salary they propose to pay the Convent for the services*/ at the rate of £55. A year for each X Ist. or 2nd Class certificated Teacher and £30 a year for each non-certificated Teacher.
- 4th With reference to the Night Schools it is proposed to make such arrangements as to rest the Sisters engaged in them by absence from the day School for [sic] on the three days of Night School, either for half a day or a whole day according to the needs & circumstances.
- 5th It is also proposed to pay the cab expenses for the Night Schools,
